

MHSA Responds to Federal Uncertainty


MHSA is deeply concerned about the Trump Administration's ongoing response to homelessness, particularly July's Executive Order "Ending Crime and Disorder on America's Streets." The order shifts policy and funding away from proven solutions like Housing First. This evidence-based approach pairs housing with wraparound services, helping people have a stable foundation of housing while addressing other challenges like mental health conditions or substance use.

Housing First has decades of proven success, with housing retention rates over 85% and reduced health care costs. The Executive Order promotes criminalization, such as camping bans, which hides the crisis instead of solving it. **Homelessness is a public health emergency**, and without treatment on demand, mental health care, long-term recovery services, and housing, people will continue to suffer.

Federal policy changes threaten to destabilize many vulnerable households in Massachusetts and make it nearly impossible for others to end their homelessness.

Unsheltered homelessness continues to rise nationwide and has doubled in Massachusetts over the past decade, highlighting the urgent need for solutions rather than punitive measures. MHSA will continue to monitor federal actions closely and advocate with state and Congressional leaders for evidence-based solutions that prioritize housing, supportive services, and public health.

Community Counseling of Bristol County

At 74, Linda lost her housing and was living in her car while dealing with COPD, heart and spine issues, and limited mobility. Now **stably housed in a Community Counseling of Bristol County program supported by MHSA's Home & Healthy for Good funding**, she feels safe and connected, has access to regular medical care, and enjoys greater independence with the use of her walker.

"[Being housed] helped me relax.

I have health issues, so I lay down when I want, I get up when I want...Whenever I need my case manager, he's right here for me. **They're very good to us.**"

Home & Healthy For Good

MHSA's Home & Healthy for Good (HHG) provides **flexible funding for permanent supportive housing** for adults who are disabled and once were chronically homeless. It also funds **critical systems change work** to further the creation of supportive housing and solutions to homelessness.

HHG advances housing solutions that save money, strengthen communities, and transform lives.

Accomplishments with HHG funding this past fiscal year (FY25) include:

Systems change to end homelessness

- Building partnerships
 with local government
 & nonprofits to develop
 alternatives to camping bans
- Convening 100* supportive housing providers statewide for monthly learning and collaboration sessions
- Promoting innovative approaches to create supportive housing quickly, like modular construction
